#### Minutes of VILLAGE OF CLEVES Council Meeting Held on August 12, 2015.

Mayor Stacy began the Council Meeting with the Pledge of Allegiance. Roll Call was taken. Ms. Rouse, Mr. Flynn, Ms. Meister, Ms. Myers, Ms. Randall and Mr. Myers were present. Solicitor Hyle and Village Administrator Rahall were also present.

#### SOLICITOR'S REPORT

The Solicitor had prepared several items of legislation for Council's consideration. The first one was appointing Dixie Colliers as the new Clerk of Council.

#### **RESOLUTION # 18 – 2015**

#### Appointing Dixie Colliers as Clerk of Council

A Motion to Adopt Resolution #18-2015, a Resolution Appointing Dixie Colliers as Clerk of Council effective retroactively to July 22, 2015 was made by Ms. Meister; seconded by Ms. Myers. ALL IN FAVOR.

Then Mr. Hyle recommended that Council approve an increase in the fees for fire hydrants that form part of the water billing for non-residents of the Village of Cleves to address the need for maintenance of fire hydrants. Hydrant fees will be increased from the present rate of \$1.00 to \$3.00 a month, effective September 1, 2015.

#### VILLAGE ADMINISTRATOR'S REPORT

Village Administrator, Michael Rahall talked about the major water main leak on Spring Street. He, Mayor Stacy, Eric Winhusen and the Engineers are meeting on Friday (8/14/15) to discuss a possible solution. There was some discussion around this issue. The Village is also in the process of putting in Pedestrian Crossings at the Library, for safety reasons. That is being funded by the Safety Route to School Grant.

#### **DEPARTMENTAL REPORTS**

#### POLICE

Acting Chief Ventre did not have much to report but did begin by announcing he and Police Officer Bingle did an intervention on two families that were having difficulties co-existing as neighbors. That has been successful.

Acting Chief Ventre recommended Hiring Luke Buhrlage and spoke of his qualifications. He asked that Council support his recommendation.

# A Motion was made from the floor to Hire Luke Buhrlage as a Part Time Police Officer at \$14.00 an hour with one year probation, made by Ms. Meister; seconded by Mr. Myers. ALL IN FAVOR.

#### Officer Buhrlage was present at the meeting and sworn in by the Mayor.

#### <u>FIRE</u>

Chief Ober began with the monthly stat totals for July. Chief Ober updated Council on a gas main on Cooper that is too close to the school. He is working with Duke Energy to address this safety issue.

#### WATER WORKS SUPERINTENDENT

Eric Winhusen had nothing special to report. Eric talked about two projects he is working on. The St. Ann's project will begin on August 18, 2015 and the GIS Mapping System will start next week also.

#### COUNCIL REPORTS

**Planning Committee, Chair** Tiffiney Myers said that a business owner wants to be added to the Business Owners Signs. She and Ms. Rouse are working on that issue. Our Zoning Inspector, Dick Weber is working with Don Mercer and Hamilton County to develop a presedure to fix or demoliab old buildings.
