#### **WATER WORKS SUPERINTENDENT**

Eric Winhusen said they are getting ready to blacktop the section of E. State Road where they were replacing the water main (between Aston View and Laurelwood) . At present there is no start date. He also said that on October 20<sup>th</sup>, 2015 the EPA is going to certify a few of his Water Works employees so they will be able to read meters at the Water Works Plant. He is working on mailers to go out to the residents to explain the Water Raise and Policy on Delinquent Bills and Shut Off Procedures.

#### **FIRE**

#### **POLICE**

Chief Jones went over his stats. He talked about the situation with the police cars. He assigned the oldest car with the most mileage to Detective Taylor to use when he is investigating a case in the Village of Cleves. The Expedition has been taken off the road. It is unsafe to drive. He is replacing the tires on the last three police cars. He also talked about the difference between leasing and buying new police cars. There was some discussion around this issue.

## **COUNCIL REPORTS**

#### **No Council Reports**

Mayor Stacy reiterated the need for Committee Meetings. The only Committees that are still in place are the Zoning & Planning Commission and Parks that will meet at a need to have basis and Finance that will meet quarterly. He suggested other Committee Meetings, outside the Village of Cleves, that Council could get involved in and better serve the Village. There was some discussion around the different committees. Mayor Stacy talked about the meeting with North Bend concerning the North Bend River Front Project. Council decided not to financially support this project with North Bend, Ohio.
