VILLAGE ADMINISTRATOR'S REPORT

Village Administrator, Michael Rahall, reported on the work that is going on for revitalizing the Business District in the Village. Mr. Rahall talked about the progress that is happening at the Old Harmony Fields and movement of Cooper Road. Ms. Rouse suggested putting that information on the Cleves Website for all of the Cleves residents to be aware of.

DEPARTMENTAL REPORTS

WATER WORKS SUPERINTENDENT

Eric Winhusen gave an update the Ohio EPA Sanitation Inspection. We had no violations and no fines. Even though the inspection was time consuming and intense, it went very well. He also gave an update on the road projects and the delinquent water bills they have been working on. Eric shared information he received from Dan Schaeffer on the proposal for the gas station in Whitewater Township. Whitewater Township is moving forward with their plans. There was a lot of discussion around this issue.

STREETS

Lucky Heath gave an overview of the things that his crew has been working on. He also wants to be involved in the sealing process again this year. If we buy two skids of sealant, we get the machine free. His crew has only used 100 ton of salt, so far this year.

FIRE

Chief Ober gave his stats for the month of January. He also expressed his concern about the Emergency Road that goes between Westgate and Coleman Woods. He would like a "STOP" sign put at the corner of Western Ridge and Westgate. He would also like a "FIRE LANE, NO PARKING" sign put at Coleman Way. There was some discussion around this issue. Chief Ober also stated that within the next month they will begin their Fire Inspections.

POLICE

Chief Jones went over his stats for the month. Officer Bingle has been certified from the State of Ohio as a Property room technician. All the Cleves officers completed Court Room Activity Training. Chief Jones attended a national conference for Police Chiefs in DC to further our vision and direction. Cleves PD has officially joined the county DUI task force. The 2008 Expedition, retired police vehicle has been sold. The Chief is having the PD garage painted white and a Taylor High School artist will paint patriotic themes on the side walls, at no cost to the Village. Ms. Rouse would like to get pictures of the garage when it is finished and share with the community. Chief Jones shared his new mission statement for Cleves Police Department with Council.
