POLICE

Chief Jones went over his stats and covered some of the incidents that have been going on in the Village this month. We did have an officer that was that was assaulted in the line of duty. There were no injuries and the officer is back to work. Officer Bingle gave an "Active Shooter" class at the Miami Township Library. The class was well received. The Library wants to include the Village Police Department in any future activities they may have. Chief Jones has completed the Standard Operating Procedures (SOP) and will give it to Solicitor Waters for review. Officers have begun Range Training. The Village of Cleves is the only West Side Agency that is doing the "Person Down" drills. Chief Jones thanked the Village for providing his full time officers with new bullet proof vests, in a timely manner. Chief Jones recognized Mike Webb for his service to the community and going above and beyond in his job. Mayor Stacy presented Officer Webb with a plaque.

Officer Luke Buhrlage is now the new compliance officer. He will work closely with Dick Weber (Zoning Official) to enforce the zoning laws in the Village.
