VILLAGE ADMINISTRATOR'S REPORT

Village Administrator, Michael Rahall, reported that Cooper Avenue is scheduled to open on August 16th or 17th. The traffic light at US 50 and Cooper Avenue is now flashing. Mr. Rahall discussed the next council meeting on September 14th. The meeting will be held at the Miami Township Town Hall. Prior to the council meeting, there will be an open house where the business district renovation plans will be on display. The Village will send invitations to the local businesses and governments and the public is welcome.

DEPARTMENTAL REPORTS

POLICE

Chief Jones went over his stats for the month. Chief Jones discussed some of the community events that the Police Department has been involved in recently such as a Cub Scout public safety event and the Three Rivers School Ready Fest. He stated that the Police SOP is complete and has been given to the Solicitor to review. The Gravelrama Parade will be August 24th. Chief Jones also discussed the recent firearms training that the Village's Police Department attended.

The Mayor commended Chief Jones and the Police Department for a job well done in what has been a very busy month.
