SOLICITOR'S REPORT

Solicitor Waters had prepared multiple items of legislation for Council's consideration.

RESOLUTION # 20-2016

TO AUTHORIZE THE VILLAGE OF CLEVES TO PREPARE AND SUBMIT AN APPLICATION TO PARTICIPATE IN THE OHIO PUBLIC WORKS COMMISSION STATE CAPITAL IMPROVEMENT PROGRAM OR LOCAL TRANSPORTATION IMPROVEMENT PROGRAM AND TO EXECUTE CONTRACTS AS REQUIRED.

A motion to adopt Resolution #20-2016 to authorize the Village of Cleves to submit an application to participate In the Ohio Public Works Commission State Capital Improvement Program was made by Ms. Meister; seconded by Mr. Flynn.

ALL IN FAVOR

Mr. Waters passed out a copy of the Public Records Policy from the Ohio Basic Code and asked that council review the document. He recommends that the Village of Cleves adopt this policy as an Ordinance at the next council meeting.

Ms. Rouse asked Mr. Waters about the new marijuana law. Mr. Waters said that Hamilton County Police Association is putting on a seminar about Legal Marijuana and how to regulate it. He suggests that the Village send a representative to this seminar.

VILLAGE ADMINISTRATOR'S REPORT

Village Administrator Rahall gave an update on the seal and patch work that is being done on Laurelwood. Mr. Rahall talked about the difference in price if you do the water/sewage bill monthly instead of quarterly. There was some discussion around this issue. He also asked that Council enter into Executive Session, for 121-21G3 Pending Litigation, at the end of the council meeting.

DEPARTMENTAL REPORTS

WATER WORKS SUPERINTENDENT

Eric Winhusen gave an update on the low water pressure problem on Colberry Court. Dan Schaefer, from Brandstetter Carrol INC. has been working with Eric on a solution to this issue. The Water Works will install a Booster Station and that will take care of the problem. The cost for this project is \$125,000 plus engineering fees. There is also a water main leak at Shawnee & Lower River Road. This problem will require coordination with the Railroad and ODOT. The water main leak will cost \$279,000 plus engineering fees. The Village will obtain a OWPC loan that will be zero percent interest over thirty years. These projects will start mid 2017.

FIRE

Chief Ober gave his stats for the month.

POLICE

Chief Jones gave his stats for the month. One specific incident required search warrants and ATF getting involved due to homemade explosive devices. Seven people were arrested with numerous felonies.

Chief Jones has two officers that were injured, last week. One in the line of duty and the other on duty at his other job. There was some discussion about staffing issues.

STREETS

Lucky Heath was absent.

COUNCIL REPORTS

<u>Safety Committee:</u> Geri Meister had a question about the Gravel Rama Parade. The parade permit was changed to reflect "no throwing candy from a moving vehicle" for safety reasons. That was not honored this year. There was a lot of discussion around this issue. Council will revisit this before the next Gravel Rama Parade.

<u>Parks Committee Chair</u> Mike Flynn would like to see a way to clean up after your pet, when in the Cleves Park. Mr. Rahall is looking into what it would cost to provide the bag holders & bags so the residents can keep the park clean, while walking their animals.
