VILLAGE ADMINISTRATOR'S REPORT

Village Administrator Mike Rahall reported that a grant application was submitted to the County for \$300,000 to be used for downtown renovations. The Village has already received \$121,000 in grant money to be used for improvements that the County recommended. Hamilton County will notify the Village if they will receive the \$300,000 grant in November. The Village has also applied for a SCIP Grant. Mr. Rahall has received a few inquiries about potential marijuana dispensaries in the Village. There will be three dispensaries in Hamilton County. Mr. Rahall reported that we have submitted information about our energy usage and energy bills to OKI to examine as part of the Energy Grant that the Village received. Someone will be coming to look at the Village's facilities as part of the grant, too. The Village will also need to hold public hearings concerning CDBG proposals.

DEPARTMENTAL REPORTS

POLICE

Chief Jones gave his stats for the month. Chief Jones reported that he is working with Homeland Security on disaster preparedness programs. The Police Department's duty phone is no longer functioning. A replacement phone is needed. The department lost two Police Officers who left for other jobs. The basement offices are almost done. The Police Officers have done most of the work themselves. The Police Officers recently had range practice at the Hamilton County Sheriff's range. Chief Jones reported that he is going to trade in old rifles for new shotguns. Chief Jones was recently interviewed by Channel 9 for a story that they are doing about drivers on drugs. Mayor Rouse thanked Chief Jones for finding ways to improve the Police Department without much expenditure.

Chief Ober gave his stats for the month.

MAINTENANCE

Service Director John Knuf reported that the department has been working on painting at the park and repainting the Village's parking lots. Mr. Knuf reported that the Maintenance Department has been helping the Water Works Department. Mr. Knuf has been working on a new sign for the park entrance. The old sign was damaged and cannot be fixed. There was discussion about the sign and who will pay for it. Mr. Knuf also reported that they will be able to use the road sealant machine at no charge when they do Village street repairs with North Bend.

WATER

Water Superintendent Eric Winhusen was not in attendance.

MAYOR'S REPORT

Mayor Rouse reported that Council is working on prioritizing items for the Village. The recently adopted Mission Statement has been posted on the website. The BLOC House is having a Fall Fest on October 28th. There will be a hay maze on the grounds of the Water Works and Administration Building. Trick-or-Treating will take place in the Village from 6 - 8 P.M. on Halloween. There is a Bicentennial Logo Contest going on. Mayor Rouse has received several submissions. Logo submissions are due October 23rd and the winner will be announced on October 30th. The Three Rivers Historical Society is going to use the Bicentennial Logo in its 2018 calendar. The calendar will be devoted to the history of the Village of Cleves. Mayor Rouse mentioned that an event management company is interested in helping with the Bicentennial celebration. The Bicentennial Committee is looking at July 2018 for a possible 2 – 3 day event. The committee needs help in reaching out to potential sponsors for the celebration. A mailing was sent to all Village residents concerning the upcoming levy. The mailing contained FAQ's about the levy. The Village's polling place has changed from the Senior Center to the School. Mayor Rouse acknowledged and thanked the following employees who had service anniversaries in September and October:

September: Mollie Hill – 19 years and Maria Neiheisel – 2 years; October: Doug Nicholas – 6 years and Mike Litteral – 5 years.

Mayor Rouse also reported that the Village has received its recycling grant for the first half of 2017. The Village received \$331. There is a group of students from Three Rivers School who would like to do a service project in the Village for their Destination Imagination competition.

COUNCIL REPORTS

Three Rivers Schools: Mr. Myers was not in attendance.
