### VILLAGE ADMINISTRATOR'S REPORT

Village Administrator Mike Rahall reported that the OKI Energy Grant subcommittee met for the third time. OKI also conducted an energy audit of each building owned by the Village. Mr. Rahall is working on an amendment to an existing ordinance that would allow the Fire Department to inspect apartments attached to businesses in the Village. The Maintenance Department had two salt trucks break down. Mr. Rahall thanked Three Rivers School District for allowing the Village to use one of their trucks. The Maintenance Department will be snow plowing two private drives this year. The residents of these drives have paid the Village a fee for the service. The Village is only plowing these two private drives because they may become public streets eventually. Mr. Rahall thanked Mr. Flynn for his service on Council.

# **DEPARTMENTAL REPORTS**

### **POLICE**

Chief Jones reported that the officers are completing their required annual training with the state. Chief Jones also reported that he is looking for new officers to fill vacancies.

#### FIRE

Chief Ober gave his stats for the month. Chief Ober reported that the two structure fires in November were both due to electrical issues. Also, the same person did not reside above Casa Loma and Suzy's Grooming as it has been rumored. The Fire Department would like to inspect apartments in buildings with businesses annually. This would help protect the public and the owner. Chief Ober thanked the Police Department for their assistance during the fire calls.

#### **MAINTENANCE**

Service Director John Knuf reported that the Maintenance Department cleaned up debris at the park from prior storms. The department also installed the Christmas decorations. The Villages of Addyston and North Bend used the Village's truck to install their Christmas decorations. Mr. Knuf reported that one of the salt trucks has been fixed and the other truck should be fixed soon. Also, the Spring Street project is on hold now due to the weather. It will continue in the spring.

### **WATER**

Water Superintendent Eric Winhusen reported that 35.27 million gallons of water was pumped in November. Mr. Winhusen reported that the water lines are complete for the Spring Street and Shawnee Projects. Construction on the Coleberry Court booster station will begin in the next few weeks.

### **MAYOR'S REPORT**

Mayor Rouse asked Council to consider the school's request to place district signs on signposts throughout the Village. There was discussion around this topic. Council decided to allow the placement of school district signs on corporate limit signs. Mayor Rouse reported that there is a Council seat vacancy for 2018 and 2019. The

vacancy has been advertised in several places including the newspaper, website and postings in the Village. Council will conduct interviews of interested candidates before the next Council meeting. Mayor Rouse recognized the following employee's service anniversary:

Eric Winhusen – 24 years with the Village in December.

Mayor Rouse thanked Mr. Winhusen for his dedication to the Village. Mayor Rouse also reported that the Three Rivers Historical Society's 2018 calendars featuring Cleves are on sale for \$10. The calendars can be purchased at the Water Works Office. The money from the calendars goes to the Historical Society. Hamilton County is creating a multi-jurisdictional disaster plan. A webinar is available for municipalities to view. Mayor Rouse thanked Mr. Flynn for his service to the Village.

# **COUNCIL REPORTS**

**Three Rivers Schools:** Mr. Myers reported that the SRO contract was discussed at the Board meeting.

**Miami Township:** Ms. Meister had nothing to report.

**Planning and Zoning:** Ms. Myers had nothing to report.

**<u>Bicentennial:</u>** Mr. Burns reported that the committee is looking at July 14<sup>th</sup> as a possible date for the Bicentennial Celebration. The committee has been discussing potential activities such as a festival, 5K and car show. Also, Miami Township has expressed interest in holding a concert in honor of the Bicentennial.

<u>Open discussion – Council:</u> Mr. Flynn thanked Council for their assistance with a parking situation in the Village.

### **PUBLIC COMMENT/ANNOUNCEMENTS**

Mr. Jeff Demaree, a resident of Laurelwood Drive, addressed Council concerning speeding on Laurelwood Drive. Mr. Demaree recently moved to Coleman Woods and has witnessed many people speeding on Laurelwood Drive. He asked Council if they could help with this issue. There was discussion concerning ways to address the problem. Chief Jones stated that the Police Department would work on it.
