This is being done as part of the OKI Energy Grant program. The Village will receive their energy audit results soon. There have been a number of water main breaks recently. Mr. Rahall thanked the Police, Fire and Service Departments for their assistance with the breaks. East State Road has been a recurrent site of main breaks due to the hill shifting.

### **DEPARTMENTAL REPORTS**

#### <u>POLICE</u>

Chief Jones reported that the calls for service were down last month due to the cold weather. Chief Jones also reported that he has interviewed several people for the open officer positions. Of those interviewed, he found one person qualified to be a full-time officer with the Village. Chief Jones reported that there have been several drug overdoses recently. There was also a child bitten by a dog on school grounds.

#### **FIRE**

Chief Ober gave his stats for the month. Chief Ober reported that there was a 10% increase in fire details in 2017 versus 2016. There was an 8% increase in EMS details in 2017 versus 2016.

### **SERVICE**

Service Director John Knuf reported that the Service Department cleaned leaves off the streets last month. Mr. Knuf also reported that the department has been helping the Water Works Department with water main breaks. The Village received the signs they ordered through the Township's grant. Mr. Knuf reported that the trucks are ready for the snow that is predicted. There was a discussion concerning snow emergencies

Water Superintendent Eric Winhusen was absent. Mr. Rahall reported that they are still negotiating a new contract with MSD.
