Minutes of VILLAGE OF CLEVES Council Meeting Held on March 10, 2021.
Meeting Held via Electronic Communications – Zoom Meeting

Mayor Myers began the Council Meeting at 7:00 P.M. with the Pledge of Allegiance. Roll Call was taken. Mrs. Brady, Mr. Williams, Mrs. Myers and Mr. Burns were present. Ms. Meister and Mrs. Peter were absent. Village Administrator Rahall and Solicitor Nicholas were also present.

Motion to Approve Previous Council Meeting Minutes from February 10, 2021 was made by Mrs. Myers; seconded by Mrs. Brady. ALL IN FAVOR.

A Motion to Adopt of Pay Ordinance #3-2021 was made by Mrs. Myers; seconded by Mr. Williams. ALL IN FAVOR.

Motion to Approve Absent Council Members, Ms. Meister and Mrs. Peter was made by Mr. Burns, seconded by Mr. Williams. ALL IN FAVOR.

HEARING OF THE PUBLIC

Steve Colina, a baseball coach, asked about the timing for the ball fields in the Park. Mr. Rahall replied that the work on the Park and Fields had started today. He also noted that the ball field dirt would be placed when the field dried out from the recent flooding.

SOLICITOR'S REPORT

RESOLUTION NO. 6 – 2021 TO ACCEPT PARCELS TITLED IN THE NAME OF THE DREES COMPANY INTO THE VILLAGE OF CLEVES

To Revise Resolution 9-2020 listing each parcel as requested by the Hamilton County Recorder's Office.

Solicitor Doug Nicholas explained that Drees requested a change in the original wording to satisfy the Recorders Office.

Mr. Burns discussed the COVID CDBG funds for the Park, which are included in the Appropriations with Mr. Rahall.

DEPARTMENTAL REPORTS

POLICE

Sgt. Schlasinger reported the following statistics for February 2021. The Department had 146 calls for service bringing the total for the year to 293. He announced that the Property Room had been successfully inventoried and the contents moved to the Sheriff's Department. He also discussed the details the Officers had responded to since the first of the year.

FIRE

Chief Brien Lacy reported the following run totals for February: 4 Fire details, and 30 EMS details. He announced that they had broke ground on the new station on East Miami River Rd, and that the Department had filled 6 new Full Time Positions.

Administrator Rahall present the Water and Service Department Reports.

SERVICE

Mr. Rahall stated that Service Director Knuf had begun the cleanup in the Park after the spring flooding. The Service Department had started pathing potholes in the roadways from the winter weather. He also noted that over 250 tons of salt had been applied over the winter and his department had 44 hours of overtime during snow events this winter.

Mr. Rahall also noted that one of our vehicles had broken down during the last snow event, likely due to the ice and heavy snow conditions and noted that we had run out of salt in the Miami Township Dome and had additional time involved in transporting salt from the County Facility in Harrison. He stated that the snow event on February 2nd and 3rd was one of the largest snowfalls recorded in our area.

Mr. Burns asked about the Park cleanup timing and discussed the upcoming season with Mr. Rahall.

WATER

Mr. Rahall stated that Water Superintendent Eric Winhusen advises 23 million gallons were pumped in February. He also reported that Mr. Winhusen was planning to advertise for bids for the repairs and painting of the water tank located on Rittenhouse.

VILLAGE ADMINISTRATOR'S REPORT

Village Administrator, Mr. Mike Rahall reported the busy month the Water and Service Departments have had due to the weather.

Mr. Rahall also said he was continuing the negotiations with the County Sheriff for police Service in the Village and discussing joint contracts. The For-Sale Sign on the Holland Property now has a "Sold Out" banner on it. He said he had nothing new to report, but was in contact with them and hoped to have news soon on the potential new development that the owner can divulge at this time.

COUNCIL REPORTS

Mayor Myers reported that there had been no Committee Meetings due to the resurgence of COVID-19. He asked if any Members had anything, they would like to bring up.

Mr. Burns expressed his desire to hold a Parks Committee meeting to discuss the COVID - CDBG Funds and the Mayor stated we would have a Parks Committee meeting in April to discuss the improvements.

Mayor Myers said he would like to return to in person meetings as soon as they can safely be conducted.




